Introduction

Gallatin County School District is a P-12 public school system located in a rural community along the Ohio River and within one hour of Lexington, Louisville, and Cincinnati. The student population is 1728 students in preschool through grade 12. Our diverse population consists of 13% of the students who qualify for special education and 13% of the student body are minority students. Additionally, 69% of the students qualify for the federal lunch program and 5.5% of our students are English Language Learners. As we serve this diverse student population, we emphasize the importance of providing equitable programs and opportunities for all students. 65.7% of our teachers have a master's degree or higher.

To ensure that all students will achieve at a high level regardless of race, gender, socio-economic status, or disability, students' needs are assessed at each level. Each school analyzes its assessment data to identify unmet needs and find ways to serve all students. The district offers art, music, band, technology, agriculture, gifted/talented classes and projects, special education, RtI intervention programs, Spanish, business, and physical education as well as a strong core content curriculum. High school students have an opportunity to attend the area technical center and participate in a dual credit program.

Teachers, administrators, and support staff care about our students and go above and beyond in serving the students. The Family Resource Center and Youth Service Center provide family support every day to those students and their families who need assistance. Many program offerings are provided to students during and after school hours. Athletics, extra-curricular activities, as well as academics, foster the culture and build a positive school climate. "Maximizing Student Learning and Achievement" defines our mission to educate young people.

"Students learn best when what we want them to know and do is rigorous and relative and we build positive relationships with them."

We embody our mission, vision and belief statements in everything we do. Our two main goals are: 1) All students are proficient on the state assessment and 2) Increase the percentage of students who are college and career ready to 68%.

Notable Achievements and Areas of Improvement

Our technological initiative continually expands with the purchase of technological equipment to increase student access to technology, upgrading wireless to N-wireless, and virtualizing our servers. Having 21st Century-equipped classrooms signifies our commitment to preparing our students for the technological world of learning and communicating. The district utilizes computer-based programs such as Odyssey, Earrobits, Fast Forward, Compass Learning, and E-Prep. The district provides high quality learning opportunities for our students to obtain skills of critical thinking, communication, collaboration and creativity.

The school district has a 94.7% attendance rate. The school's College and Career Readiness data results showed that 49.1% of the seniors were college and/or career ready. The Graduation Rate (5-year Cohort) for 2014 graduates was 95.3% exceeding the state graduation rate of 89.2%.

We plan to continue working to improve the delivery of RtI to better assist students that are behind in the achievement and to enrich students in furthering their experiences.

We are working to develop a culture of education and learning beyond high school. The expansion of Leader in Me program into the schools helps foster a climate where students take ownership of the culture in which they are educated. In addition, the district will continue to decrease achievement gaps, increase rigor, and prepare students for college and career.

We continue to improve communication with community and stakeholders through focus groups: certified staff, classified staff, parents, business/community, senior citizens, high school students, and middle school students. Data analyzed for the needs assessment included, but was not limited to, K-PREP data, School Report Card data, ACT, EXPLORE, PLAN data, MAP data, KOSSA, COMPASS, WorkKeys data, attendance data, ESS data, TELL Survey results, as well as other formative and summative assessment information.

The team reviewed all assessment data and from that data, goals objectives were developed for the CDIP. Modifications to the 2013-2014 CDIP were made to update percentages of needed increase in academic content areas and graduation rate. New strategies were added to address non-duplicated gap group category. Also, more focus was placed on the College and Career component.

Areas of Strengths

What were the areas of strength you noted? What actions are you implementing to sustain the areas of strength? What is there cause to celebrate?

The Graduation Rate improved and exceeded the state Graduation Rate. The Upper Elementary School and High School met its Annual Measurable Objective (AMO) Goal. Data showed increases in our averaged combined reading and math scores for elementary and end-of course scores.

Opportunities for Improvement

What were areas in need of improvement? What plans are you making to improve the areas of need?

As a district, we will look at closing the gap for the non-duplicated gap group in reading and math. Activities will target College and Career Readiness. The High School will continue to implement the Quality Core curriculum and utilize E-Prep to increase ACT scores. More intentional strategies will be designed to address Career Pathways for high school students. We will increase the number of students who are enrolled in CTE Career Pathways and the number of students earning industry certifications and/or passing the KOSSA exam for career readiness. In addition, strategies and actions will address curriculum alignment, evaluation of assessment strategies, as we continually monitor and modify instruction to meet student needs and support proficient student work. We will provide professional development to address the goals of the plan and include parental communication and involvement.

Oversight and Monitoring

The staff will continue to review interim assessments, MAP scores, goals progress and make changes in instruction as needed. The district will monitor continuous improvement through CIITS. Principals report progress to the SBDM and the board on a monthly basis.
